RESPONSIBILITIES OF VENDOR

- A) Vendor will not give or sell space in its booth for advertisement and / or promotion to a third party
- B) Vendor agrees to operate with regulations set forth in the California state Health and Safety Code & he /she must be individually permitted, where applicable, to operate by the state of California.
- C) Vendor agrees to pay all fine / penalties levied to organizer and to reimburse organizers any fine / penalties levied to organizers as a result of vendor non-compliance with any Federal, California State and local law including, but not limited to OSHA.
- D) Booth must be set and ready by 2:00pm for inspection
- E) Contract and fees are due by June 30th.
- F) Price for each item must be displayed.
- G) Booth Fee only include the space and vendor must leave the booth clean after the event
- H) Registration fees include: One Booth with lighting, 2 tables, & two chairs.
- I) Vendors brings their own banner / sign (Banner size – 6'x3')
- J) Caterers are responsible to dispose their own left over charcoal and cooking oil.
- K) Vendor booth location will be at the discretion of organizers
- L) Any support vehicles required by the vendor must be parked in the appropriate area as Designated by the organizers
- M) Vendors must keep their booth clean and organized at all time.
- N) Vendor is responsible for warmers, and hand washing buckets
- O) Vendor must bring a fire extinguisher and vendor must be comply with the guideline for Propane tank usage.
- P) Vendor must bring disposable gloves and caps.
- S) All payments must be made in the form of a check or money order in advance by due date. **No cash payment accepted or any payment accepted at the event.** All returned check will be subject to \$50 NSF Fee and replaced payment will be accepted only in the form of Money order or Cashier's Check.
- T) The booking of the booth is final and non-cancellation. There will be no refund once the payment is received. **This is final sale.**
- U) Vendors are **not allowed** to modify any light fixers provided in the booth. The organizers and their certified electrician, prior to usage in the booth, must approve all string/portable or other lights brought in by the vendor. Non-certified lights and power cord/extension cord will not be permit in the booth.

The vendor / its affiliated companies, and subsidiaries agrees to be responsible for, and to Defend, hold harmless, and indemnify organizers, Pakistan Independence Day 2026, and their Members, including reasonable attorney fees, of liability whether by injury (including death) to The person or property of another or otherwise arising in connection with this agreement.
